### **FDOT to Host Nov. 28 Hybrid Public Meeting for Proposed Improvements to Beach Boulevard (State Road 212)**

**JACKSONVILLE, Fla.** – The Florida Department of Transportation (FDOT) will host a public meeting inviting citizen input and questions regarding proposed modifications as part of the Beach Boulevard (State Road 212) from west of 12<sup>th</sup> Street to A1A resurfacing project (FIN 445420-1) and safety project (FIN 447359-1). In addition to milling and resurfacing, improvements include bike lanes, ADA sidewalk upgrades, driveway modifications along Beach Boulevard, updates to signal and lighting and the construction of traffic separators.

The hybrid public meeting will be held Monday, Nov. 28 at the Church of Our Savior, 2092 Beach Boulevard, Jacksonville, FL 32250. Project staff will be available to answer questions and accept comments in-person, online at [nflroads.com/VPH](http://nflroads.com/VPH) or by phone at (914) 614-3221, access code 191-127-383.

Citizens may drop by anytime between 4:30 and 6 p.m. to learn more about the scope of the project, offer input and view conceptual renderings of the project. A formal public comment period for both in-person and virtual participants will begin at 6 p.m.
