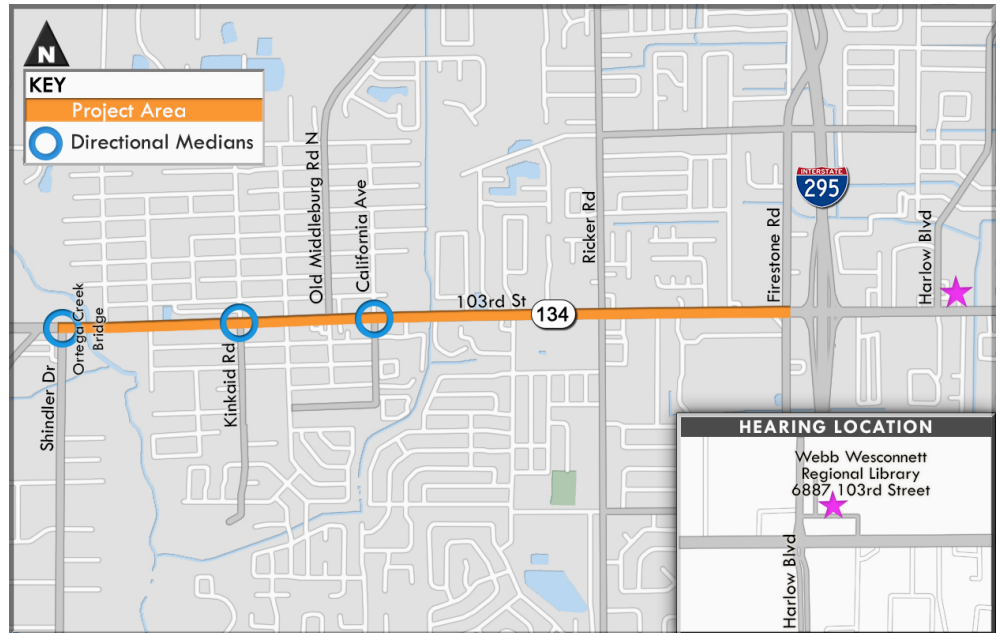

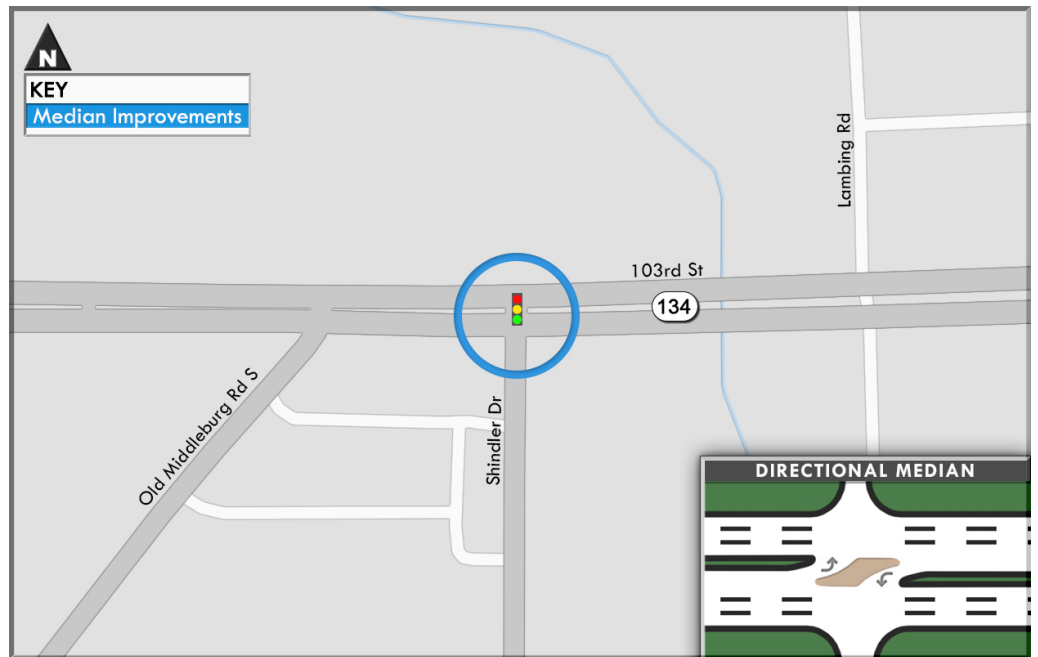
The Florida Department of Transportation (FDOT) is hosting a public hearing to discuss median modifications on 103rd Street at Shindler Drive, Kinkaid Road and California Avenue. To reduce angle and side collisions at these intersections, FDOT proposes the installation of directional medians, preventing through-traffic and left turns onto 103rd Street. (See *median renderings on back*.) In addition, medians and turn lanes east and west of Kinkaid Road and California Avenue will be modified to facilitate safe U-turns. The proposed changes will be included in the 103rd Street resurfacing project from Shindler Drive to Firestone Road which is scheduled to begin in summer 2023.

To provide citizens with an opportunity to share input on the proposed changes, FDOT will host a public hearing **Thursday, June 23, 2022**, at the Webb Wesconnett Regional Public Library at 6887 103rd Street, Jacksonville, FL 32210. The meeting is also available online at nflroads.com/VPH or by phone at **914-614-3221**, **access code 834-495-747**. An informal open house will be held from 4 to 6 p.m., during which attendees may ask questions and discuss the project with members of the project team. A formal public comment period will begin at 6 p.m.

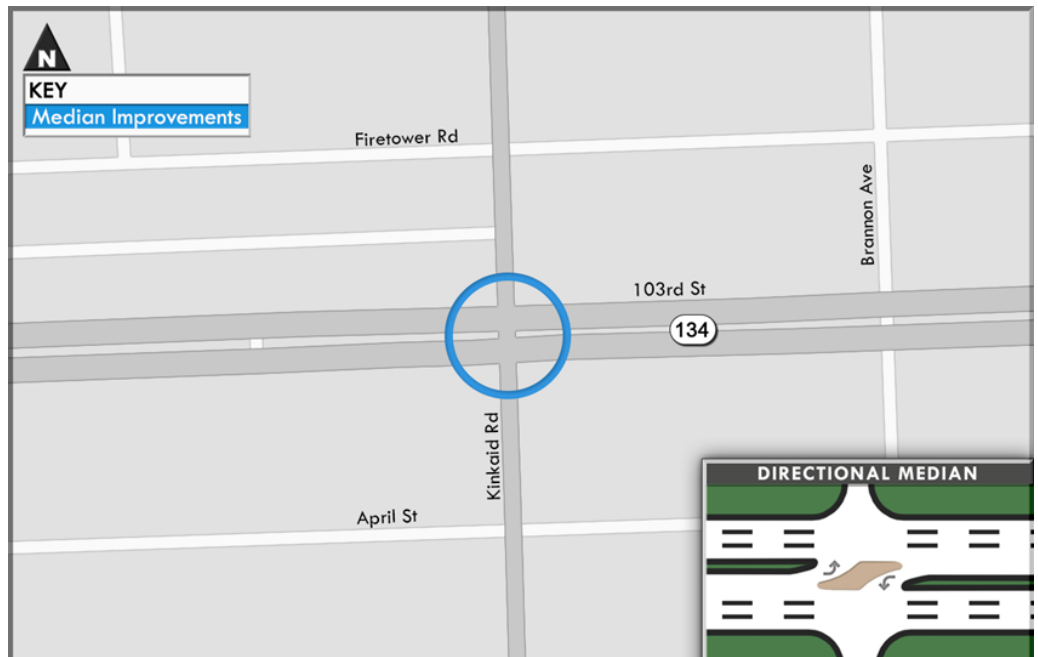
